## IMAC REPORT GRADING THE RESPONSE OF CONGRESS TO THE CLIMATE EMERGENCY

Interfaith Moral Action on Climate (IMAC) is a non-partisan collaborative initiative of faith and spiritual leaders, groups, and individuals that acknowledges that the climate emergency is the greatest moral issue facing our nation and all of humanity today. Despite ample warnings from the U.S. National Academy of Science and the academies of science from almost every nation on Earth, the U.S. Congress has failed to meaningfully address the rapidly deepening crisis. This is a moral and ethical failure of the highest order.

This document is not a normal voters guide. It does not seek to educate the public about a candidate's voting record. It is provided so that IMAC members know where members of Congress stand on climate disruption—the most important moral issue of our time.

Note that IMAC neither supports nor opposes any candidates for public office and this report card does not constitute IMAC's endorsement or opposition of any Congressional candidates.

### **THE MORAL IMPLICATIONS OF THE CLIMATE EMERGENCY**

IMAC believes climate disruption is the most pressing moral issue of our time for three reasons: First, because left unchecked it will produce untold unjustifiable human suffering and death here and abroad. Second, because the people and nations that have contributed the least to the problem will, at least initially, be impacted the most. Third, because it will disrupt Earth's ecosystems, which sustain all Creation.

## METHODS

In this report card, the position of a member of Congress on the climate emergency is determined by how they fare on three issues:

- Q1. Do they openly acknowledge that the Earth's climate is changing primarily due to human activities?
- Q2. In their reelection campaigns and/or ongoing work do they openly talk about the seriousness of the impacts associated with unchecked climate change and that it is thus a moral issue that requires new policies to address?
- Q3. Do they demonstrate a personal commitment to addressing the climate emergency by voting affirmatively on energy and emissions legislation deemed significant by the League of Conservation Voters?

Members were given a rating of A, C, or F on each question, with an A being good, C being modest or unsure, and F being poor. The ratings for questions 1 and 2 were determined by examining written statements on their websites as well as internet searches for news stories describing comments the member may have made. The rating for question 3 was determined by examining the League of Conservation Voters record of key 2011 climate, air and energy votes. We were purposely generous in our ratings: a score of 70-100% was given an A, a score of 50-69% was given a C, and 49% and below was given an F. We apologize for any errors or omissions that might have been made. We encourage any member of Congress that believes their position on the climate emergency has been misrepresented to contact us with appropriate documentation and mistakes will be quickly rectified.

## **SUMMARY: CONGRESS GETS AN 'F-' — BUT NEEDS AN 'A+' ON CLIMATE DISRUPTION**

Although a number of House and Senate members have exemplary personal records on climate disruption—based on the criteria used in this report card. Congress as a whole has failed to meaningfully address the most pressing moral challenge of our times. The majority of members fail to openly acknowledge that human-caused climate change is occurring and left unchecked will produce the human suffering and death, inequality, and degradation of the natural environment that make it a deeply moral issue. Few members regularly talk about climate change in their reelection campaigns and/or ongoing congressional work. And Congress has failed to enact policies to meaningfully and rapidly address the climate crises.

The implications of this mass failure of moral and ethical conduct are vast and deeply disturbing, not just for all Americans and people around the world, but for our children and all future generations as well. Humanity needs every member of Congress, and Congress as a whole, to rapidly achieve an A+ on climate disruption. The whole world is watching. What Congress does now and in the immediate future will shape the future of our planet.
